In a shocking finding, the Crime Branch has reported that fake lottery tickets are in widespread circulation across the state. The police have also found big bundles of fake lottery tickets at some lettery efficie in the state. lottery offices in the state. According to a senior Crime Branch official, a

According to a semior Crime Branch official, a suo motu case has been registered based on the initial findings. A report was also handed over to State Police Chief Loknath Behera by IGP (Crimes) two days ago. The Super intendent of Police, Palakkad, has been entrusted with the case as more incidents were reported from the

"We are taking the case very seriously. Widespread circulation of counterfeit lottery tickets has come to our notice. Most incidents have been reported from Palakkad, Ernakulam and Thrissur districts. Two to three cases were also reported in Thiruvananthapuram district. We suspect that an inter-state mafia is behind the big pres-ence of fake lottery tickets in the state. We will also consider setting up a special squad for the investigation based on the number of cases reported," a Crime Branch officer told 'Express'

ported," a Crime Branch officer told "Express". The police also suspect that fake tickets are printed using the plates which were used at government press. The police will also probe whether any such plates in government press were shifted with the knowledge of staff.
When contacted, Loknath Behera said that the lottery maffa might have strong links with operators abroad. "We will seek the support of Interpol as there were reports that the tickets were printed outside the country. But we can't confirm this. The Crime Branch is looking into the case", he said.

Earlier this month, the Thir uvananthapuram City Shadow Police had busted a fake lottery rack-et in the district and arrested four persons in con-nection with the fraud. The accused were running three-digit 'handwritten lottery' number business under the guise of a Kerala state lottery agency.

ATTENTION fortune seekers! The next time you AITENTION fortune seekers! The next time you approach a lottery vendor to buy a ticket, you might get duped, as the ticket could be a fake. In a shocking finding, the Crime Branch has report-ed that fake lottery tickets are in widespread cir-culation across the state. The police have also found big bundles of fake lottery tickets at some lottery of fives in the critic.

According to a senior Crime Branch official, a motive ase has been registered based on the initial findings. A report was also handed over to State Police Chief Loknath Behera by IGP (Crimes) two days ago. The Superintendent of Police, Palakkad, has been entrusted with the case as more incidents were reported from the district.

"We are taking the case way soriustly Wide."

district.
"We are taking the case very seriously. Wide-spread circulation of counterfeit lottery tickets has come to our notice. Most incidents have been reported from Palakkad, Ernakulam and Thris-sur districts. Two to three cases were also report-ed in Thiruvananthapuram district. We suspect

that an inter-state mafia is behind the big pres-

that an inter-state maffa is behind the big presence of fake lottery tickets in the state. We will also consider setting up a special squad for the investigation based on the number of cases reported," a Crime Branch officer told 'Express'.

The police also suspect that fake tickets are printed using the plates which were used at government press. The police will also probe whether any such plates in government press were shifted with the knowledge of staff.

When contacted, Lokanth Behera said that the lottery mafia might have strong links with operators abroad. "We will seek the support of Interpol as there were reports that the tickets were printed outside the country. But we can't confirm this. The Crime Branch is looking into the case", he said.

Earlier this month, the Thiruvananthapuram
City Shadow Police had busted a fake lottery racket in the district and arrested four persons in connection with the fraud. The accused were running three-digit 'handwritten lottery' number

Fake lottery tickets: Int'l link suspected

ATTENTION fortune seekers! The next time you approach a lottery vendor to buy a ticket, you might get duped, as the ticket could be a fake. In a shocking finding, the Crime Branch has reported that fake lottery tickets are in widespread cir-culation across the state. The police have also found big bundles of fake lottery tickets at some

lottery offices in the state. According to a senior Crime Branch official, a suo motu case has been registered based on the initial findings. A report was also handed over to State Police Chief Loknath Behera by IGP (Crimes) two days ago. The Superintendent of Po-lice, Palakkad, has been entrusted with the case as more incidents were reported from the

"We are taking the case very seriously. Wide-spread circulation of counterfeit lottery tickets has come to our notice. Most incidents have been reported from Palakkad, Ernakulam and Thrisir districts. Two to three cases were also report ed in Thiruvananthapuram district. We suspect

that an inter-state mafia is behind the big presence of fake lottery tickets in the state. We will also consider setting up a special squad for the investigation based on the number of cases re ported," a Crime Branch officer told 'Express'

The police also suspect that fake tickets are printed using the plates which were used at government press. The police will also probe whether any such plates in government press were shifted with the knowledge of staff.

When contacted, Loknath Behera said that the lottery mafia might have strong links with opera-tors abroad. "We will seek the support of Interpol as there were reports that the tickets were printed outside the country. But we can't confirm this. The Crime Branch is looking into the case", he

Earlier this month, the Thiruvananthapuram City Shadow Police had busted a fake lottery racket in the district and arrested four persons in connection with the fraud. The accused were running three-digit 'handwritten lottery' number business under the guise of a Kerala state lottery

We are taking the case very seriously. Wide spread circulation of counterfeit lottery tickets has come to our notice. Most incidents have been reported from Palakkad, Ernakulam and Thris-sur districts. Two to three cases were also reported in Thiruvananthapuram district. We suspect

that an inter-state mafia is behind the big pres-ence of fake lottery tickets in the state. We will also consider setting up a special squad for the investigation based on the number of cases reported," a Crime Branch officer told 'Express'

a shocking finding, the Crime Branch has reported that fake lottery tickets are in widespread circulation across the state. The police have also found big bundles of fake lottery tickets at some lottery offices in the state.

According to a senior Crime Branch official, a suo motu case has been registered based on the initial findings. A report was also handed over to State Police Chief Loknath Behera by IGP (Crimes) two days ago. The Superintendent of Police. Palakkad, has been entrusted with the case lice, Palakkad, has been entrusted with the case as more incidents were reported from the

district.
"We are taking the case very seriously. Wide-spread circulation of counterfeit lottery tickets has come to our notice. Most incidents have been reported from Palakkad, Ernakulam and Thris-surd districts. Two to three cases were also report-ed in Thiruvananthapuram district. We suspect

that an inter-state mafia is behind the big pres-ence of fake lottery tickets in the state. We will also consider setting up a special squad for the investigation based on the number of cases reported," a Crime Branch officer told 'Express'

ported," a Crime Branch officer told 'Express'.

The police also suspect that fake tickets are printed using the plates which were used at government press. The police will also probe whether any such plates in government press were shifted with the knowledge of staff.

When contacted, Lokanth Behera said that the lottery mafia might have strong links with operators abroad. "We will seek the support of Interpol as there were reports that the tickets were printed outside the country. But we can't confirm this. ATTENTION fortune seekers! The next time you approach a lottery vendor to buy a ticket, you might get duped, as the ticket could be a fake. In a shocking finding, the Crime Branch has report-ed that fake lottery tickets are in widespread cir-culation across the state. The police have also found big bundles of fake lottery tickets at some

found big bundles of Take lottery tickets at some lottery offices in the state. According to a senior Crime Branch official, a suo motu case has been registered based on the initial findings. A report was also handed over to State Police Chief Loknath Behera by IGP (Crimes) two days ago. The Superintendent of Po-lice, Palakkad, has been entrusted with the case as more incidents were reported from the

"We are taking the case very seriously. Wide-spread circulation of counterfeit lottery tickets has come to our notice. Most incidents have been reported from Palakkad, Ernakulam and Thris r districts. Two to three cases were also reported in Thiruvananthapuram district. We suspect also consider setting up a special squad for the investigation based on the number of cases re-'a Crime Branch officer told 'Express

The police also suspect that fake tickets are printed using the plates which were used at government press. The police will also probe whether any such plates in government press were shifted with the knowledge of staff.

When contacted, Loknath Behera said that the lottery mafia might have strong links with operators abroad. "We will seek the support of Interpol as there were reports that the tickets were printed outside the country. But we can't confirm this. The Crime Branch is looking into the case", he said.

Earlier this month, the Thiruvananthapuram City Shadow Police had busted a fake lottery racket in the district and arrested four persons in connection with the fraud. The accused were running three-digit 'handwritten lottery' number business under the guise of a Kerala state lottery

ATTENTION fortune seekers! The next time you approach a lottery vendor to buy a ticket, you might get duped, as the ticket could be a fake. In a shocking finding, the Crime Branch has reported that fake lottery tickets are in widespread cir-culation across the state. The police have also found big bundles of fake lottery tickets at some

tottno tig bundles of take lottery tickets at some lottery offices in the state. According to a senior Crime Branch official, a suo motu case has been registered based on the initial findings. A report was also handed over to State Police Chief Loknath Behera by IGP (Crimes) two days ago. The Superintendent of Police, Palakkad, has been entrusted with the case as more incidents were reported from the

district.
"We are taking the case very seriously. Wide-spread circulation of counterfeit lottery tickets has come to our notice. Most incidents have been reported from Palakkad, Ernakulam and Thris-sur districts. Two to three cases were also report-ed in Thiruvananthapuram district. We suspect

that an inter-state mafia is behind the big pres-ence of fake lottery tickets in the state. We will also consider setting up a special squad for the investigation based on the number of cases re-ported," a Crime Branch officer told 'Express'.

The police also suspect that fake tickets are printed using the plates which were used at government press. The police will also probe whether any such plates in government press were shifted with the knowledge of staff.
